The RSUs shall be satisfied over a four-year period, as follows: (a) 15.5% of the grant to vest on September 15, 2024; (b) 7.75% of the grant to vest on each of December 15, 2024 and March 15, 2025; and (c) for each quarter starting June 15, 2025, the grant will vest 5.75% per quarter thereafter.
